3. Oklahoma City Fire Department Report – Chief Richard Kelley

Major Lance Jones presenting: MIH program started buprenorphine induction program with first participant in February. Working on high utilizer planning to reduce utilization of 911 emergency services. Civilian ambulance EMTs and paramedics recent additional five hires with plans for fourth ambulance to be at Station 6 in Bricktown.

4. Tulsa Fire Department Report - Chief Michael Baker

LifePak 35 19 being implemented to date with an additional 4 to be deployed asap pending technical updates. UE scope with 25 uses to date and uploading videos. Whole blood administration has no contacts to date (since July 3rd implementation in Tulsa) and working to change deployment plans, tentative plans to pause carrying if needed to conserve resources. MIH program with 5,000+ responses, doubling prior year responses. ART-2 expanding to seven days a week. Will hire a non-sworn paramedic in April to work on that team. Dr. Cody working with MIH team for opioid response planning. Crisis intervention training for de-escalating training will be doing healthcare-centric curriculum in mid-March. "Pop up clinic" (street clinic) will start March 19th at Boston Avenue United Methodist Church with multiple social services agencies.

5. EMSA President Report – Johna Easley

EMSA response time compliance performance was provided to the MCB. Ms. Easley's comments included district chief work in mitigating hospital-based bed delays. UE scopes deployed since February 1st. LifePak 35 is planned to be deployed April 1st-15th depending upon training schedules. Switching from ESO Alerting (OKC) and radios (Tulsa) to Pulsara software for "encoding." CAPCE, CoAEMSP, and Simulation Center accreditations in process.

6. Chief Medical Officer/Associate Chief Medical Officer Reports

Dr. Goodloe updated the MCB on activities completed by the OMD team in the interim since the January MCB meeting.

Dr. Goodloe briefly highlighted the numerous meetings that the OMD team continues to have with agencies within the EMS system, including orientation academies as well as the long-established monthly CQI meetings led by OMD.

Dr. Goodloe reviewed recent field implementation of video laryngoscopy. Exact numbers of intubations are still pending, though consensus feedback is positive on the

equipment and a sense of improved first pass intubation success. Formal research review to follow.

Dr. Goodloe highlighted national conference presentations and research abstract presentations at the NAEMSP Annual Meeting in January (Light & Siren reduction through clinical outcomes based call prioritization, whole blood administration program implementation in EMS, and sleep disruption medical oversight consults for the EMS physician; BLS tiering and aspirin use and documentation in suspected acute coronary syndrome patients.

Dr. Goodloe co-presented a national webinar on waveform capnography for ems1 last month. Typical registrations are about a hundred with 80% or so attending. This webinar garnered over 750 pre-registrations with over 300 attendees.

Dr. Goodloe congratulated the OMD team for successful acceptance of three didactics presentations at EMS World, the National Association of EMTs Annual Conference in October 2025 - 1) whole blood administration in EMS; 2) biostatistician use in an EMS system; and 3) commercial in-flight medical emergencies.

Dr. Goodloe and Duffy McAnallen visited the City of Tulsa Public Safety Commissioner Laurel Roberts, and she is invited to attend MCB meetings on an ongoing basis.

Dr. Goodloe also updated the MCB on pending additional data continuing to support utilization of BLS ambulances for 911 response, with desirable performance in the three variables of key interest: return to hospital red lights and sirens, ALS ambulance assist activation, and unstable vital signs.

Dr. Cody discussed work in progress with MIH programs at Oklahoma City Fire Department and Tulsa Fire Department.

Matt Cox is leading the system-wide support team in analytics issues with the new LifePak35s being implemented system wide. There are numerous technical issues to ensure correct data collection and that being shared with OMD to continue our system-wide CPR database and analysis.

MCB physicians received the divert reports, compliance reports presented earlier by Ms. Easley and the hospital destination reports.
